PARLIAMENTARY QUESTION NO. 1432

Mr M.J Cuthbert (DA) to ask the Minister of Trade and Industry:

- (1) With reference to his reply to question 1107 on 22 June 2020, (a) on what type of leave are the two officials in the Industrial Financing Branch who have not reported for work since 2019, (b) for what period of time has each of the two officials been on the specified leave and (c) why were the names of the specified two officials not included in his reply to question 1107 on 22 June 2020;
- (2) whether, since his reply to the question, he has received any additional names of any persons who are on sabbatical and/or any other extended leave; if so, what are the relevant details?

REPLY

 The information asked for in Parliamentary Question 1107 covered the leave cycle period 1 January 2019 to 31 December 2019.

I am advised that Ms Mabitje-Thompson was not on sabbatical leave during this period. The approved sabbatical leave for Ms Mabitje-Thompson covers the period 16 March 2020 to 25 September 2020.

I am further advised that Mr MS Sithole was on sabbatical leave, for the period 1 March 2019 to 30 November 2019 and his details were left out of a previous schedule as a result of an administrative error. Due to this oversight, the Branch re-checked all records and verified sabbatical leave records

against Persal reports. A manager was found to be responsible for the administrative error and received a formal caution.

In future, the records will be captured on Persal on a weekly basis and monthly reports submitted to Chief Director; Human Resources for control purposes.
