She also received a Lifetime Achievement Award at the WOZA Women in Law Awards and was recently given a special recognition award from the Black Lawyers Association for her commitment, leadership, and contribution to the transformation of the legal profession, judiciary, and the organisation. She holds the following qualifications: BProc, LLB, and a Certificate in Arbitration, Mediation and Dispute Resolution.

## Professor Darren Subramanien Associate Professor at UKZN

Professor Darren Subramanien lectures in the fields of Commercial Law, Corporate Law and the Law of Contract at the School of Law. He lectures these modules at both undergraduate and at postgraduate level. He is also the Academic Leader for Socio-legal studies at the Pietermaritzburg Campus. He holds a Bachelor of Laws (LLB) degree, a Master of Laws (LLM) and PhD in Company Law from the University of KwaZulu-Natal (UKZN). Prof Subramanien is also an admitted Advocate of the High Court of South Africa. He was a member of the Anti-Human Trafficking task team based in KwaZulu-Natal and is on the panel of legal experts for Legalwise where he provides legal advice in the areas of commercial, company and labour law. Prof Subramanien has been a facilitator for the department of Legal Education & Development (LEAD) for over 10 years where he lectures Constitutional Practice, Legal Drafting and Dispute Resolution to Candidate Attorneys. He is currently on the editorial committee for the Journal of Corporate and Commercial Law & Practice and is a registered commercial and civil mediator.



## Judge Dennis Davis **Companies Tribunal's Chairperson**

Judge Dennis Davis is the Chairperson of the Tribunal. He is also a member of the Commission of Enquiry into Tax Structure of South Africa and was a Technical Advisor to the Constitutional Assembly where negotiations for South Africa's interim and final constitutions were formulated and concluded. He previously served as the head of the Competition Appeal Court and the Tax Appeal Court. He was appointed a Judge of the High Court in 1998 and as President of the Competition Appeal Court in 2000. Since his appointment to the Bench, he has continued to teach constitutional law and tax law at UCT where he is an Honorary Professor of Law. He has been a visiting lecturer/ professor at the Universities of Cambridge, Florida, Toronto and Harvard. He holds the following qualifications: BCom LLB from the University of Cape Town and an MPhil from the University of Cambridge.



## **Mr Ebrahim Patelia Director of Mediate Works**

Mr Ebrahim Patelia is the Head of Mediate Works (Pty) Ltd and a legal consultant at Cliffe Dekker Hofmeyr (CDH) law firm, specializing in employment law. He is a respected mediator, arbitrator, facilitator, and trainer, blending his legal expertise with dispute resolution and teaching experience. While primarily based in South Africa, Patelia has worked internationally. He chairs disciplinary inquiries, leads investigations in conflict-prone areas, and supports organizations in understanding and implementing diversity and inclusion strategies.
