# QUESTION FOR WRITTEN REPLY

### QUESTION NO. 2188

### Dr A Lotriet (DA) to ask the Minister of Trade, Industry and Competition:

What (a) total amount did the Sport and Recreation Distributing Agency receive in each financial year since its inception, (b) total amount was spent in each specified financial year on (i) salaries and/or allowances, (ii) office rentals, (iii) the sponsoring of events and all relevant details in this regard, (iv) travelling and accommodation and (v) any other specific costs and (c) total amount in funding was received for the development of sport? #### REPLY

I have been furnished with a reply to the question submitted, by Ms Thabang Mampane, Commissioner of the National Lotteries Commission, which is reproduced below.
