### 1. PURPOSE

- **1.1 the dtic** would like to inform you about the latest enhancements and improvements in the submission of Export Marketing and Investment Assistance (EMIA) individual applications.
- 1.2 To improve our response time to applications and claims, the dtic has implemented an Online Incentive Solution (OIS), which allows prospective applicants to submit online applications without having to travel to the dtic offices. The OIS will improve service delivery, turnaround times and tracking in finalising applications and claims, providing the status of applications at all times during processing.

#### 2. DETAILS OF IMPLEMENTATION

- **2.1** As from 1 September 2022, all applications must be submitted via the OIS platform available at <a href="https://oisportal.thedtic.gov.za">https://oisportal.thedtic.gov.za</a>
- **2.2** As from 1 September 2022, EMIA Individual Participation will no longer accept applications that have been submitted through email or hand-delivered.
- **2.3** The OIS platform will not accept late applications. Applications must be submitted three to six months before the commencement date of the event.
- **2.4** The online application process, list of required documents, and guidance on how to apply will be posted on **the dtic** website and communicated to all stakeholders.
- **2.5** Claims and reports will be available on the portal (<a href="https://oisportal.thedtic.gov.za">https://oisportal.thedtic.gov.za</a>) one day after the date of the event.

- **3.3** Assistance for Individual Inward Bound Missions (IIBM): Applications are to be submitted manually until further notification.
