AN INTRODUCTION TO THE INDUSTRIAL FINANCING GROUP

The Industrial Financing Group (IFG) provides multiple financial support programmes managed by three institutions, **the dtic** through the Incentive Branch (IB), Industrial Development Corporation (IDC) and the National Empowerment Fund (NEF).



Industrial financing is offered in the form of grants, loans and equity. While this presentation focuses on the financial support offered by the IFG, the IDC and NEF also offer non-financial support to business clients.

This support is offered through the different stages of a transaction with initial mentorship/training to capacitate entrepreneurs to run their businesses and concludes with turnaround strategies and or business rescue.

The presentation provides an overview of the performance of IFG based on applicable and key indicators from **the dtic's** 2023/24 Annual Performance Plan.


It tells a story of outcome and impact of funded projects based on the available data for the 2023/24 financial year and highlights impacts such as:

- Green Industrialisation.



The 2023/24 performance information will be used as a baseline for measuring IFG's performance over the next 5 year period (2025-2030)


THEORY OF CHANGE DEPICTING HOW THE WORK OF IFG RESULTS INTO IMPACTS







During 2023/24, output produced by funded manufacturers and local spend by funded film productions contributed significantly to the South African economy:






EXPORTS TO AFRICAN COUNTRIES AND OTHER GLOBAL MARKETS

Exports to African Countries and other Global Markets









MANUFACTURING

R10 billion disbursed to over 330 projects operating in the manufacturing sector.

These projects reported over **67 000** jobs (of which over 14 000 were new jobs) and approximately **R15.4 billion** additional local output manufactured in the country.

Exports amounted to **R117 billion** of which over **R10 billion** were destined for African countries.


24% was disbursed to black-owned manufacturers, 21% to SMMEs, 6% to women-owned and 3% to youth-owned.



- To effectively compete with global manufacturers, South Africa needs to embrace [industrial automation](#) and artificial intelligence as a catalyst for change. Apart from technologically advanced automated machinery and equipment, upskilling and reskilling of the labour force is required to address the needs of the evolving manufacturing sector.
- Over the next 5 years, IFG will be focusing on funding value-adding, beneficiating, low energy and high tech manufacturing projects that are substantial creators of new jobs.
- The IB and the IDC aim to intensify funding initiatives to new electrical vehicles including funding to local component manufacturers in the automotive industry.
- Development of a Tax incentive to attract new investment in manufacturing in order to expand the current range of locally produced goods for the domestic and global market.



SA COMPONENT MANUFACTURER GRADUATES FROM INCUBATION PROGRAMME


BACS was established in 2017 by Mr Siphon Batyi and is a tier 3 components supplier to Ford through Motherson Sumi System Ltd (MSSL) (Motherson) – tier 3 is where lower levels of manufacturing and assembly operations take place such as the production of plastic injection moulded sub-components, pressed steel sub-components, nuts and bolts.

BACS is a black-owned and managed company that has been operating under the Automotive Industry Development Centre (AIDC) Incubation Program for the past 5 years. AIDC is an initiative of the Government to promote automotive industrial manufacturing by building automotive industrial parks and incubation parks to service Original Equipment Manufacturers in the country.

Through this initiative, BACS has been assembling components for Motherson - a global Tier 1 components supplier with 270 facilities in 41 countries - and has since graduated from the Programme and awarded its own contract.

INCREASED EXPORTS BY OEM


Ford Motor Company SA is a light motor vehicle manufacturer based at the Tshwane Automotive Special Economic Zone. The company was approved funding through the Automotive Investment Scheme to upgrade the new Ford Ranger Model and the Amarok model for Volkswagen South Africa as well as to manufacture the engines for both models. The total investment made to date is R8.5 billion in new machinery and production equipment as well as tooling.

The company reported the creation of 647 new jobs and retention of over 4 800 existing jobs. Of these total jobs supported, over 5 000 are black employees, 1 700 women, 2 800 youth and 40 are persons with disabilities. These employees are mainly from areas surrounding the plant.

The number of new Ranger and Amarok vehicles manufactured increased from 85 000 at approval to 95 000 as at 31 March 2024 and the company is exporting 70 000 vehicles to over 135 countries world wide. The top three export markets consists of the United Kingdom, Germany and Austria.

LARGEST MANUFACTURER OF WHEELS/RIMS IN THE SUB-SAHARAN REGION


Global Wheel (Pty) Ltd, based in Heidelberg, Gauteng, is a black-owned business established in March 2005. It is the largest manufacturer of commercial, agricultural, earthmoving and military steel wheels/rims in the Sub-Saharan region.

The NEF initially funded the company with R54 million and later approved R4.2 million through the Alternative Energy Fund in order to assist the company to continue operating during loadshedding. These investments assisted Global Wheel in retaining approximately 193 jobs.

Some of their customers include companies such as Bell Equipment, Basil Read Mining, Exxaro Coal and General Motors.

INCENTIVES ENABLING LOCAL PRODUCTION OF COMPONENTS PREVIOUSLY IMPORTED

Thekwini Wire and Fasteners is a black-owned SMME component manufacturer of automotive exhaust mounting hanger brackets for light vehicles. The company, which is based in Prospecton in eThekwini Metropolitan Municipality, KwaZulu-Natal, is supplying components to the automotive industry since 2012.


In June 2021 the Automotive Investment Scheme approved Thekwini to invest in an expansion project which enabled the company to introduce four new types of exhaust bracket products that were previously imported from the Netherlands.

100% of the company's raw materials are procured from local suppliers of which 26% of the input materials are procured from black-owned suppliers. Thekwini has retained 27 jobs with all the employees hired from nearby townships such as Umlazi, Chatsworth, Sezela, Umgababa and Phoenix.

BLACK INDUSTRIALIST MANUFACTURING HDPE PIPES


Dika Plastics (Pty) Ltd is a black-owned company manufacturing plastic pipes, specifically high-density polyethylene (HDPE) pipes and related fittings for industry use. HDPE pipes are more durable, flexible and cheaper to transport and install compared to the concrete and steel pipes.

The company, located in Middleburg in the Gert Sibande District Municipality, Mpumalanga was approved for the Black Industrialist Scheme to invest in production equipment and machinery as well as commercial vehicles. The transaction was co-funded by the NEF for an additional amount of R39.1 million which went towards the acquisition of manufacturing machinery testing equipment, delivery vehicles and the installation of an alternative energy source and working capital.

Dika Plastics has sustained 7 jobs, created 11 new jobs and plans to create additional 18 jobs once fully commissioned by the end of 2024. The company's employees are from the surrounding Townships of Hlalamnandi and Mhluzi.

ROCKY BRANDS INFILTRATING DOMINATED MARKETS

Infiltrating a market dominated by long-established household brands with loyal followers takes guts and confidence. Fortunately, Rishav Juglall has these qualities in bucketloads. The youngster, buoyed by his marketing and economics background, founded Rocky Brands in 2011 after he discovered he could undercut retailer pricing on many goods. This realisation came when his mother asked him to buy a glass top-stove cleaner, which he found at a leading store.

Much curiosity and some research later, Rishav found a similar product manufactured by Weiman in Illinois, United States. At the time, it was Walmart's top-rated brand. He captured the attention of Weiman executives after he submitted a sales pitch to introduce its product range in South Africa. So taken aback were these decision-makers that they sent Rishav free samples to test the market. It would prove a clean sweep for all concerned.


Between 2015 to 2018, the Rocky team bottled its products by hand, buying a desktop filler only in 2018, when it relocated from Durban to Johannesburg and opened a 2000m² manufacturing facility at Riversands incubation hub.

Impressed by the ingenuity of the entrepreneur and his great chances of success, the IDC approved funding to enable Rocky Brands to expand and ensure its products meet the stringent requirements of South Africa's leading retailers.

There seems little doubt that this will transpire, as Rishav is cleaning up in other areas too, having been recognised as one of the country's most enterprising and innovative youngsters, having scooped top honours in the Ferro Coating Resins Group Durban chemical cluster competition, followed in 2022 by the Pick n Pay supplier of the year title.


PROUDLY SOUTH AFRICAN CLOTHING MANUFACTURER



The company identified a demand of concrete related products in the growing mining town of Mokopane. This growth is propelled by existing and developing mining activities which are driving the residential, commercial and industrial segments in the developing municipality of Mogalakwena.

The company is currently owned by its 2 founders, Tshigo Seletela and Tshephisho Nailana – youth, black females who with the investment from the IDC are setting up a brick manufacturing plant.

RECYCLING END-OF-LIFE TYRES TO HIGH VALUE END-PRODUCTS

Mandini Group (Pty) Ltd is a black-owned commercial enterprise recycling end-of-life tyres to high value end-products. Mandini is operating a facility in Gauteng and Mpumalanga for over 7 years. Since inception, the facility has processed over 70 000 tons of tyre waste as a registered Waste Bureau processor. The facility processes waste tyre material into four sets of products: oil, steel, carbon black and gas.


In 2021, the NEF approved an investment of R9 million to improve operating productivity and efficiency while minimising safety hazards.

In 2023, a further investment of R38.98 million was approved for expansion and vertical integration. The business will be establishing a tyre cutting business (to process mining tyres) as well as a recovered carbon black milling business. The investment has resulted in the creation and retention of 141 jobs.

BLACK INDUSTRIALIST TURNING WASTE INTO PELLETS



The company, located in the townships of Kraaitfontein and Phillipi, in the City of Cape was approved by the Black Industrialists Scheme to expand its current operations through the establishment of the low density polyethylene (LDPE) plastic pelletising division. The LDPE will be used as a raw material during the manufacturing of plastic refuse bags.

This green industrial project is aligned with the National Development Plan's Vision 2030 for environmental sustainability and resilience.



BLACK INDUSTRIALIST TRANSITIONING TO GREEN ENERGY SOURCES

Irwing 310 (Pty) Ltd t/a Topsteel is a black-owned entity (75% women and 25% youth-owned) established in 2000 as a close operation and later converted to a private company in July 2010.


The company is based in Kuils River, Cape Town and operates in the steel fabrication/manufacturing sector, supporting the food and allied industries and critical electrical distribution industries. It manufactures sub-assembly parts used in the production of commercial bakery ovens, in South Africa as well as globally. It also manufactures transformer housings.

Topsteel was approved through the NEF's Alternative Energy Fund for R9.2 million to install 496 solar panels, to purchase an industrial generator and obtain finance for working capital. The financial support will assist the company to reduce its dependency on the Eskom's electricity grid and retain 41 full time jobs.




SA'S FIRST 100% BLACK-OWNED MINING MANUFACTURING FACILITY


Mohlalefi Engineering (Pty) Ltd, a black-owned business was approved by the NEF to fund a feasibility study that assessed the viability of the pilot mining support system and accessories manufacturing facility.

The pilot was deemed as economically viable and exceeded all targets of the feasibility study. Situated in Alberton, Gauteng, the project is now entering the construction and operation phase in the establishment of a commercial scale plant. The full investment required for this is R117 million and will result in the company retaining 70 jobs and creating more than 400 new jobs by 2027.

The NEF approved R35.7 million for this phase with the remaining R81.3 million funded by the Industrial Development Corporation and **the dtic's** Black Industrialist Scheme.

PIPELINE STELLANTIS PROJECT

Stellantis is geared to accelerate domestic motor manufacturing with the promise of 50 000 new vehicles leaving its Eastern Cape production line annually. The world’s fourth largest OEM in its sector, plans to produce the recently launched Peugeot Landtrek bakkie. This extends Peugeot’s longstanding history in South Africa, which dates back to the 1960s and has spawned 82 dealerships.


The IDC, courtesy of its mandate to fast track the growth of the automotive and transport industry, is comfortably in the passenger seat, having approved funding to establish the manufacturing plant in which all the Stellantis import replacement and export revenue generation action will take place.

The plant will produce petrol and diesel vehicles, with the capability to switch to both battery and plug-in hybrid variants of the Landtrek. Local production of the fuel cells for this bakkie is being researched. In addition to its funding, the IDC is setting up the Stellantis NewCo workers trust, enabling employees of the company to have equity.

In this partnership, the IDC takes its lead from the South African Automotive Masterplan whose aim is to bolster the country’s competitiveness in vehicle assembly. The project looks certain to attract further key investments, given its strategic contribution to positioning Eastern Cape as a leading automotive hub in sub-Saharan Africa.

AGRICULTURE




R6.7 billion disbursed to 40 agri-business projects. These projects reported 800 total jobs (of which over 400 were new jobs) in various agriculture industries including poultry, nuts, medical cannabis, forestry, fruit and animal farming. Overall, disbursements to projects located in the districts outside of the 5 metros comprised **88%**, evident of the aim of IFG to provide inclusive industrial financing across the country.

R302 million was disbursed to 14 black-owned agri-businesses and R325 million was disbursed to 22 SMMEs and women-owned projects, with the latter reporting over 620 jobs. In the next 5 years, the IDC will be working with industry partners to catalyse the commercialisation of black farmers into the “protein” value chain.

To reduce the current challenges faced by this industry due to weather variability, the IDC is investigating climate-resilience initiatives, such as financing drought-tolerant crop varieties, efficient irrigation systems and ‘smart’ agriculture technologies and farming techniques.

Another strategic project that will increase the economic contribution of this industry, is a feasibility study being conducted on producing polylactic acid from cane. Polylactic acid, used in the production of bioplastics, is being viewed as a possible alternative to country’s sugar exports.



A START-UP IN THE MEDICAL CANNABIS INDUSTRY

Belhes is a start-up company that aims to construct, obtain license, operate and manage a medicinal cannabis growing and processing plant, based in Gqeberha, Eastern Cape. The company was established by Chief Heston David Botha in 2017. Since then, Belhes partnered with several Khoi cannabis growers to conduct research and development, under SAHPRA research license, on the best cultivation methodology between hydroponic and open field growing and harvesting. The process was conducted over a 12-month period, with indoors hydroponic system considered the best method.

The company started investing in the land, construction material and equipment to kick-start the commercial cannabis production and processing plant in a controlled environment. As part of IDC's role in developing a medical cannabis value chain, funding was approved to Belhes to construct, ensure licensing and operate the plant.

Medical cannabis is a job rich industry as it is a hand-picked high value crop. South Africa has the required expertise in the horticulture and pharmaceutical sectors to capitalise on the growth of medical cannabis. IDC has a significant role to ensure that historically disadvantaged individuals also benefit in this growing industry by playing a proactive approach in the development of this new industry.

AGRIBUSINESS ENSURING FOOD SECURITY IN NORTH WEST

KMF Holdings is a mixed agriculture business comprising a poultry operation, three cattle studs, and cash-crop farming of maize and sunflowers. It owns most of the 3,500 ha of land on which it operates in Lichtenburg and the Magaliesberg, having acquired properties in 2014, 2016, and 2019, and leasing more land in 2020.


KMF is now poised for the next major step in its evolution, with the support received. The company applied for funding to build a red-meat abattoir, a feedlot, and a rendering plant, all of which are necessary facilities for KMF to successfully grow into its next phase.

The IDC funding will allow KMF to supply customers directly and once its facilities are operational, KMF will be able to directly supply retailers, wholesalers, and butchers as well as build an export market. KMF's growth trajectory means a leap in job creation, with an expected 104 positions that will be added to the current 40. While the new jobs will primarily be for farmworkers and managers, KMF will be growing its administrative capacity as well. Employees are given in-service training on the farms.

AGRIBUSINESS ENSURING FOOD SECURITY IN LIMPOPO


Northroost (Pty) Ltd is a start-up agribusiness operating a commercial hatchery in Makhado, Limpopo. Owned and operated by 28-year-old Clive Tigere, it supplies formal and independent markets in and around Limpopo.

Established in 2017, initially hatching 1 000 eggs weekly, it now aims to become Limpopo's second-largest hatchery on the back of strategic partnership with established poultry businesses for technical support.


Roadgrass Investments, a black-owned and managed agribusiness, was established 15 years ago by the Mabogoane family. Their operations encompass broiler production and livestock activities, including cattle, sheep, ducks, and goats. The primary focus is on broiler chickens.

The business runs a fully commercial chickens broiler business in Delmas, Mpumalanga and livestock operations in Balfour, Mpumalanga. The chickens are sold typically at approximately 33 days old, the ideal age for slaughter-ready broilers in South Africa.




ELECTRICITY, GAS AND STEAM SUPPLY: ECONOMIC ENABLER



R1.6 billion disbursed to 18 projects involved in the supply of electricity, gas and steam. Funded projects will add **1 521MW** of new generation capacity once fully operational.

These projects reported over **2 000** jobs and invested over **R7 billion** (investment multiplier of 4) during 2023/24, both of which is an indication of the importance of this industry not only to address the challenges of the current energy shortage, but also to contribute significantly to employment and inclusive economic growth in the country.




ELECTRICITY, GAS AND STEAM SUPPLY: ECONOMIC ENABLER

In fact, 53% of the funding was accessed by black industrialist and black-owned projects and 98% was disbursed to projects located outside the 5 main metros.

Of particular mention is the IDC's renewable energy projects in the Northern Cape which includes: Solar photovoltaic (PV) Plants with Battery Energy Storage System (BESS) located in Kenhardt, the Solar Thermal Power Plant in ZF Mgcawu District Municipality, and the Wind Farms in Pixley ka Seme District Municipality.

In 2024/25, the focus will be to fund low carbon energy projects such as natural gas, which is viewed as a transition energy source, progressing with hard-to-abate industries and implementing the commercial industrial portfolio offtake model to fast-track construction of utility-scale renewable energy projects.





RENEWABLE ENERGY AND WASTEWATER TREATMENT


BBEnergy partnered with the **In2Food Group** to form a special purpose vehicle called **In2Energy** for the design, construction and operation of various small scale rooftop Solar Photovoltaic and effluent/water treatment plants.

In2Energy will supply the In2Food facilities with Solar Photovoltaic Renewable Energy and Wastewater Treatment services for their processing plant facilities located across the country. The project portfolio will include a total of 9 projects (five rooftop solar and four water treatment projects), with an estimated total development cost of over R50 million.



BBEnergy is an engineering company that has been in existence since 2010 and specialises in solving complex engineering problems in the energy and water fields. They also have specialist knowledge in water treatment process design and management, which is key for the successful construction and operation of the proposed effluent treatment projects. In2Food is a premium prepared food and beverage business that competes in both the local and international markets, across a wide-ranging portfolio including fresh and frozen produce, prepared meals, fish, juice and bakery products.




PELE GREEN ENERGY PROJECTS POWERING AHEAD ALONGSIDE GLOBAL PLAYERS


The four founders of **Pele Green Energy**, a black-owned vertically integrated independent power producer, were in their 20s when they took the renewable energy plunge. Fifteen years on, they fulfil multiple roles in the value chain and includes sponsor, shareholder, developer, operator and renewables asset manager. With the IDC by their side, they are well on their way to satisfying their vision of largescale structural transformation in the sector. The partnership, now in its 11th year, is formalised through HoldCo, an entity intended to streamline funding processes, reduce borrowing costs and enhance funding efficiency to expedite the development of projects.

The IDC has invested directly in Pele Green and in other Pele group entities, furthering the company’s investments in Redstone CSP, Khanyisa IPP and Knowledge Pele. Indirect support includes senior debt in project vehicles in which Pele Green has a minority stake. During 2023/24, the Corporation advanced finance to enable the organisation to acquire equity in eight projects and to fund project development activities. With this new bottom-line boost, Pele will add 1 045MW of energy capacity to South Africa’s economy and create 2 372 new construction and operational jobs.

This winning partnership is one of the country’s first portfolio-funding transactions in which a local independent power producer enjoys substantial support from local lenders. It reflects the IDC’s commitment to fostering a competitive environment for black producers to power ahead alongside global players. Over the last eight years, Pele has grown from a preferred minority black economic empowerment partner in Renewable Energy Independent Power Producer Procurement Programme projects to lead sponsor in utility-scale projects with commercial and industrial sector off takers.

LARGEST RENEWABLE ENERGY INVESTMENT PROJECT IN SOUTH AFRICA

The IDC invested R1.6 bn in an R11.6bn 100 MW salt molted concentrated solar power (CSP) project, **Redstone**. The project is led by Acwa – a Saudi based desalination plant and renewable energy operator, in partnership with Pele Green Energy, CEF and Community. The project’s technology uses a tower that contains salt and when heated by mirrors, it reflects sunlight in a process known as concentrated solar thermal power.


Located in the Northern Cape town of Postmasburg, the 100MW Redstone CSP plant forms part of the country’s Renewable Independent Power Producer Programme (REIPPP). It is the first project-financed CSP with molten salt central receiver in the world and one of the largest investments in South Africa under the REIPPP.

IDC provided funding to Pele Green energy – a black-owned South African IPP, Bowwood and Main community trust on a 50/50 partnership with Acwa. This project ranks as one of the largest renewable energy investments in South Africa.

The Redstone plant will be equipped with a 12-hour energy storage system – a first of its kind for South Africa – and will, once operational, deliver reliable and clean electricity to 200 000 households during peak demand periods, even well after the sun has set. Redstone is expected to have an operational life of more than 30 years. Once operational, it will provide significant economic spin-offs to the Northern Cape economy in the form of massive employment opportunities.




INDUSTRIAL INFRASTRUCTURE: ECONOMIC ENABLER



R1.2 billion disbursed to 27 infrastructure/construction projects that invested **R11 billion**, resulting in an investment multiplier of 9. Funded projects during the year reported over 800 active jobs and over **1 300** construction jobs.

76% of the funding was for the construction of bulk infrastructure (such as fuel storage facilities, water and road infrastructure) and top infrastructure mainly in 6 Special Economic Zones as well as the refurbishment of 3 Industrial Parks. Two of these parks are encouraging digitisation and technology through digital hubs.



To address the challenges experienced by funded Industrial Parks, **the dtic**, through the Spatial Industrial Development Branch is collaborating with the Development Bank of Southern Africa to improve and tighten governance of the funding model. In addition to this, a [new Industrial Park model](#) is also being developed that will increase opportunities for township and rural economies supply chains as well as require working with provinces, local government and their funded agencies to ensure sustained impacts emanating from Industrial Parks.

BOTSHABELO IP


The main purpose of the Botshabelo IP, located in the Free State, is to create employment for the community members and the surrounding areas, attracting investment, and encouraging manufacturing. The renovation has attracted R500 million investment so far and created 5 000 permanent jobs through the full functionality of 108 factories. The Botshabelo IP also features a digital hub, launched in 2022, serving as a centre of excellence to promote digitalisation and industrialisation.

SESHEGO IP

The refurbishment of 11 factories/warehouses in the Seshego Industrial Park was approved in July 2021. One of these warehouses are earmarked to be a digital hub that will empower youth and unemployed people from nearby communities through digital, cross-cutting as well as information and communication technology, skills training and providing access to work spaces that encourage collaboration work and information sharing amongst start-up accelerator programmes and business incubators. To date, the design and layout for these factories was completed and SMMEs appointed for work that has started on all 11 factories/warehouses, including the one earmarked as a digital hub. As part of the refurbishment, 14 local SMMEs were contracted and 141 construction jobs were created with employees hired from the local communities in the Capricorn District Municipality. The construction is 65% complete.



Ongoing Refurbishment of a Warehouse (Source: DBSA)




INDUSTRIAL PARKS WITH DISBURSED FUNDING IN 2023/24

UPINGTON IP

The Upington Industrial Park was approved in July 2021 for Phase 1 to invest in security and road infrastructure, as well as storm water drainage and electrical infrastructure. The park is the central point of the Northern Cape industrial corridor and is situated close to the Upington airport. It aims to attract investors operating in renewable energy, aviation, agro-processing, automotive and business incubation industries as well as reduce poverty and unemployment in the district.

To date, the park's design and layout has been completed, the site established and 20 SMMEs appointed for some of the construction work. The construction of a high security metal invisible fence, as well as three guard houses, roads, fences and storm water drainage is 93% complete. As part of the construction, 20 local SMMEs were contracted and 69 construction jobs were created with these employees hired from the local community.






CRITICAL INFRASTRUCTURE SUPPORT FOR FARMING COMMUNITIES

Middelburg Vineyards (Pty) Ltd project is located in the Cape Winelands District Municipality, Western Cape. The project farms wine grapes which are then processed and bottled for the domestic market and exported to various countries. Other products farmed and processed include citrus, cherries and almonds.

The Critical Infrastructure Programme funded the project for the construction of a dam as well as a pipeline for water distribution and a **power line** to assist with the pumping of bulk water during the drought season. This project will also benefit the large farming communities in Langeberg and Overberg.

CONSTRUCTION PROJECT CREATING JOBS AND IMPROVING TOURISM


Ocean Umhlanga (Pty) Ltd, based in eThekweni, was approved R22.5 million for the construction and expansion of public transport facilities such as roads, a taxi rank, concrete walls and lateral support road pieces along the Corner of Lighthouse Road and Lagoon Drive, along the Radisson Hotel at Umhlanga Rocks.

The construction project is 40% complete and has created 6 231 construction jobs. Once completed the project is expected to reduce traffic congestion in the area. This will reduce the travel time to commuters from nearby townships, reduce the delay of deliveries, increase safety on the roads and reduce the number of accidents. Improvement of roads will benefit the hospitality industry as Umhlanga is a holiday destination for domestic and international travellers.

WORLD CLASS INDUSTRIAL HUB IN TSHWANE

Rosslyn Hub is a mixed-use development located in the heart of Rosslyn, in the City of Tshwane. The Hub is a R500 billion investment project planned for over a 50-year period that will enable the integration of a new world-class logistics node and vehicle distribution centre. It aims to make Tshwane the automotive capital for vehicle manufacturing in Africa.


It was approved for the Critical Infrastructure Programme to construct bulk infrastructure, inclusive of a new road and bridge, widening lanes for existing roads and traffic circles. So far, the Hub reported an investment of R20 million that employed 58 construction workers. The project is also creating working opportunities for communities in the greater GaRankuwa, Soshanguve and Winterveld areas.

Once the CIP project is completed, it is envisaged that the new and improved roads will enable easy access to the Hub and link it to the N4 highway and Transnet's freight link.

UPTOWN WOMEN-OWNED COMPANY TRANSFORMING CONSTRUCTION INDUSTRY


Uptown Trading CC, a black women-owned company, with head offices in Bloemfontein, Free State, provides electrical contracting and construction that includes installation of infrastructural work (electricity) in new townships, RDPs, and informal settlements.

Ms du Toit initially acquired 51% of the business and subsequently acquired the balance of the shares making her the sole owner of the business. Through these transactions, the business shareholding has been fully transformed.

The NEF funded the expansion of Uptown Trading in the Free State, Eastern Cape and Western Cape, by providing funding of R4.5 million to scale up equipment in order to deliver on additional contracts. Through this transaction, the business retained 18 jobs and created 8 new jobs.


Wurthmore Concrete (Pty) Ltd is a black-owned business, established in 2021 in Kimberley, Northern Cape and manufactures concrete for the construction industry.

To meet rising demand and address breakdown challenges experienced by the plant, the NEF approved funding of R6.8 million. This financed a new concrete batching plant and three mixer trucks, boosting production capacity and securing Wurthmore Concrete's role as the region's primary ready-mix concrete supplier.

The funding supported the company to create 6 new jobs and retained 10 jobs.




R256 million was disbursed to 9 projects operating in the mining industry, of which all are operating outside of the 5 main metros. SMMEs accessed 37% of the funding and reported 279 jobs of which 129 was created during the financial year. Women-owned and youth-owned accessed, 26% and 7%, respectively.

In order to increase the participation of BO miners (who accessed 36% of the funding), the IDC in partnership with the Department of Mineral Resources and Energy launched the Junior Mining Exploration fund in February 2024. This fund aims to:

- Assists qualifying enterprises to conduct exploration
- Provides black junior miners with access to finance
- Promotes economic inclusion to support equitable economic growth

The IDC will continue to explore investment opportunities in critical minerals linked to renewable energy and new energy vehicles.




MINING



63% of the funds disbursed in 2023/24 was for a Copper Zinc mining project in the Pixley ka Seme District Municipality, Northern Cape.

The mine was initially shut down in 1991 but due to rising global prices for these metals, the IDC funded the revitalisation of the mine to complete a trial mining exercise and installation of dewatering equipment which will enable access to the main hoisting shaft and the mineral reserves.


Once fully commissioned, the mine is expected to produce more than 248Kt copper and 800Kt zinc and create significant employment opportunities in the area. As Copper is a good conductor, it has several applications in areas such as electricity, electronics, transportation, chemicals as well as electric vehicle manufacturing.




WOMEN-OWNED COMPANY PROVIDING SPECIALIST SERVICES TO THE MINING INDUSTRY

Maduka Resources CC is a black women and youth-owned business, accredited by the international institute of welding to offer mining operation services in the specialist area of mechanical and civil engineering since 2010.

The business, which has its head office in Witbank, Mpumalanga and also operates in Limpopo, was approved R6.6 million to help retain 45 jobs and create 35 new jobs. The company employs majority of its employees from local communities.

BLACK-OWNED LOGISTIC FIRM EXPANDING IN UNTRANSFORMED INDUSTRY


Established in 2014, **NJM Projects & Supplies Pty Ltd** is a black youth-owned, full-service logistics company providing transportation services in the mining and related sectors. The company is based in the John Taolo Gaetsewe distric, Northern Cape and is predominately involved in the transportation of manganese from the Northern Cape to the ports of Saldanha Bay and Port Elizabeth.

NJM evolved into a prominent player in the logistics industry, with plans to grow even further in this predominantly untransformed industry. To support this expansion, the IDC provided expansion capital that will go towards the purchase of additional trucks and trailers.

This transactions is one of many, that originated as part of the IDC's SME-CONNECT partnership programme, through which opportunities such as these are leveraged from the Enterprise Supplier Development programmes of corporates and fall under the IDC's Small Business Finance and Regions Division whose main objective is to support SMME's and regional economic growth.




WHOLESALE AND RETAIL TRADE

R164 million was disbursed to 26 projects operating in the wholesale and retail industry, of which all are black-owned SMMEs that reported over 1 400 active jobs.

NEF funding to this industry included the sale of automotive fuel, food and beverages, paints and glass, pharmaceuticals and medical goods.

Districts of retail locations include the Thabo Mofutsanyana District Municipality in the Free State, uMgungundlovu District Municipality and Zululand District Municipality in KwaZulu-Natal, Ehlanzeni District Municipality and Nkangala District Municipality in Mpumalanga as well as the John Taolo Gaetsewe District Municipality in the Northern Cape.




WHOLESALE AND RETAIL TRADE



The NEF will be implementing the following during the next year:

- Strategically positioning smaller retailers to induce demand for agriculture businesses (food and other agro-processing) and manufacturers (like furniture);
- Enhancing the focus on independent black retailers in townships to ensure sustainability of these businesses so that local customers have access to smaller retailers apart from the large supermarkets. Smaller retailers also tend to sell niche products used by the community that most supermarkets don't stock; and
- Funding franchises as it remains a relevant entry point for novice entrepreneurs given its blueprint approach.




WOMEN-OWNED BUSINESS EXPANDING TELKOM'S FRANCHISE

Mafoko Global (Pty) Ltd is a black women-owned business established by Ms. Refiloe Mafoko. The business began trading in 2021 as part of Telkom's Enterprise Supplier Development Programme. After successful completion of the mentorship program in July 2023, Mafoko Global was appointed as the 1st women franchisee in the Telkom network and awarded 23 new Telkom stores, in addition to the initial 11 stores, resulting in total of 34 stores.

Mafoko Global sourced funding from the NEF to the value of R15 million to fund the capital required to operate the 34 allocated Telkom stores, which are in North West, Free State, Northern Cape and Gauteng. The investment will maintain 71 and create a further 189 new jobs.


They've signed an agreement with KZN Oils (Pty) Ltd to co-develop an Astron Energy Service Station in Nongoma, KwaZulu-Natal. Having obtained all necessary rights and approvals, the National Department of Mineral Resources and Energy has granted licenses for fuel dispensing.

The NEF approved R15 million to OL Family Pride towards financing the Astron Energy service station and Fresh Stop C-Store development. The transaction is anticipated to create 30 new jobs, furthering economic growth in the region.





Foreign and local productions spent **R3.6 billion** in the South Africa economy during filming and post-production, of which 6% was procured from black suppliers.



industry. These projects reported approximately **33 000** incentivised jobs in the industry and

exported **R7.3 billion** of services to countries such as the United States of America, United Kingdom, Australia, New Zealand, Netherlands, Gibraltar, Canada and Mauritius. It costs IFG an average of R16 500 to incentivise one new job.

The trend of moving towards high-value services continued to be evident in 2023/24 and includes examples of online English tutoring, financial and insurance administration, risk management and data analysis services as well as recruitment of medical staff for hospitals and nursing homes.

Considering that over 80% of active jobs in this industry are youth, IFG will continue to invest in this industry and encourage projects with new locations in townships as well as those jobs that are more digitally-orientated. To increase employment opportunities, the IB will be collaborating with the industry's stakeholders that will provide training to unemployed youth on work readiness and digital skills required by operators.

Agilus Solutions, a black female-owned company based in the City of Johannesburg, Gauteng, is operating since 2017, providing software solutions to various industries.



SMART PARKING TECHNOLOGY TO EASE CONGESTION AND IMPROVE CONVENIENCE

K2014171689 (Pty) Ltd t/a Hotstuff Innovations, is a black youth-owned SMME located in the East London Industrial Development Zone in the Buffalo City Metropolitan Municipality, Eastern Cape. It was established in 2014 to create research and innovative concepts and to develop technologies for various industries.

The company was approved for funding through the Support Programme for Industrial Innovation Programme in order to develop a digital parking management system featuring a user-friendly interface that will display real time occupancy of parking bays across municipalities in both rural and urban areas.


Users will be able to download the parking app on their smart phones, which will show them the occupancy status of parking bays before they arrive at the parking area and also pay for the parking with a QR code.

The patent for the proof of concept for this app was registered and published in October 2020. To develop the prototype, Hottstuff Innovations hired 13 employees, of which 10 are from the Mdantsane, Duncan Village and Zwelitsha townships.

Hotstuff Innovations is targeting Buffalo City, Nelson Mandela Bay and Mangaung Municipalities to initially roll out this product. The prototype of the app is projected to be completed and tested by September 2025.

SOWETO TECH COMPANY SEEKS TO IMPROVE EDUCATION IN POOR COMMUNITIES



LOL Tech received funding support through the IDC's Khoebos Innovation Promotion Programme (KIPP) for the acquisition of assets and working capital. Funding support has enabled the company to commercialise innovative technology solutions that seek to improve the quality of education in underprivileged communities and in the process helping to address the challenges facing the South Africa's education sector.
