### QUESTION FOR WRITTEN REPLY

#### QUESTION NO. 1672

##### *Ekandustria Industrial Park*

**Mr N H Pienaar (Limpopo: DA) to ask the Minister of Trade, Industry and Competition:**

- (1) (a) Who is the title deed holder of the Ekandustria Industrial Park that is located in Bronkhorstspruit in Gauteng which is operated by the Mpumalanga Economic Growth Agency, (b) what is the current debt to the City of Tshwane Metropolitan Municipality and (c) which subcontractor is currently appointed to manage administration of the park;
- (2) whether he will provide a full breakdown of all tenants in the said park, including (a) their names, (b) their monthly rental fees and (c) the number of employees; if not, why not; if so, what are the relevant details? CW1896E

#### REPLY:

I have been advised as follows.

- (1)
- (a) The title deed holder for the Ekandustria Industrial Park is MEGA, under the original Deed of Transfer Nr. T28799/1994; and is located in Bronkhorstspruit, Gauteng.

(b) According to MEGA, the current debt to the City of Tshwane Metropolitan Municipality is approximated at R360 million. They further stated that the amount is in dispute due to, among other things, historically incorrect billing.

(c) The appointed subcontractor that does facilities management at the industrial park on behalf of MEGA, is Property Solutions at the White House. The company has been given a 3-year contract, which started in Quarter 1 of the 2024/25 financial year (i.e. from April 2025).

(2) (a)&(c) The below is a breakdown of the current tenants' information in the park:
