## **Appointment of Consultants**

Mr H J Van den Berg (Northern Cape: FF Plus) to ask the Minister of Trade, Industry and Competition:

- (1) Whether his department has appointed any consultants (a) in 2023 and 2024 and (b) from 1 January 2025 up to the latest specified date for which information is available; if not, what is the position in this regard; if so, (i) which consultants, (ii) for what periods of the contract and (iii) at what cost in each year;
- (2) whether any of such consultants were appointed to assist his department in the execution of its mandate as a result of insufficient capacity and vacancies; if not, what is the position in this regard; if so, (a) which consultants, (b) for what periods of the contract, (c) at what cost in each year and (d) what will it cost to fill such vacancies in each year:
- (3) (a) for what purposes were consultants being appointed other than the filling of vacancies, (b) which consultants were appointed in this regard, (c) for what periods of the contract and (d) at what cost in each year? CW987E

#### **REPLY:**

(1) (a)

The Department appointed consultants in 2023/2024, and from 1 April 2025 up to date, the details are attached as **Annexure A**.

The main purpose for appointing consultants was to supplement the existing skills within the Department. While **the dtic** is staffed with qualified personnel, the consultants were brought in to provide specialised knowledge, technical expertise, or additional capacity for specific projects or initiatives.

The consultants were not brought in to replace existing staff, but rather to offer focused support that enhanced the Department's internal capabilities. Their contribution allowed **the dtic** to tap into current industry best practices, gain valuable external perspectives, and advance work on complex or time sensitive projects more efficiently.
