QUESTION NO. 4085

Mr R W T Chance (DA) to ask the Minister of Trade, Industry and Competition:

With reference to the Equity Equivalent (EE) provisions of the Broad-Based Black Economic Empowerment (B-BBEE) Act, Act 53 of 2003, (a) on a scale from 0% to 30% of the value of the company committed to its B-BBEE programmes, how does this translate into points on the Ownership element of the BBBEE scorecard, (b) which additional companies has his department and/or BBBEE Commission engaged regarding implementing EE programmes and (c) what (i) percentage of multinational firms operating in the Republic have registered an EE programme with the B-BBEE Commission, (ii) engagement has his department and the B-BBEE Commission initiated with foreign chambers of commerce and other international institutions such as the International Monetary Fund and World Bank regarding the impact of B-BBEE regulations, including EE, on foreign direct investment in the Republic and (iii) were the outcomes of such engagements? REPLY

- (a) The determination of contribution to under the Equity Equivalent Investment Programme (EEIP) is either based on 4% of the company's South African based revenue or 25% of the value of the company's SA asset, or as stipulated by that specific sector code. The maximum number of points that an entity can receive under the EEIP is 25 points if a multinational company is fully compliant.
- (b) The Department and the B-BBEE Commission engage with multinational companies, business associations, and chambers to create awareness about B-BBEE including EEIP.
- (c) Multinational companies that have participated in EEIP are listed in the table below.
