Mr A D Beesley (ActionSA) to ask the Minister of Trade, Industry and Competition:

Since his reply to question 1885 on 5 December 2024, what (a) is the complete breakdown of all (i) international and (ii) domestic travel undertaken by (aa) him and the (bb) Deputy Ministers, (b) was the purpose and justification for each trip, (c) was the date and destination(s) of each trip, (d) were the total costs incurred, disaggregated by transport such as airfare and vehicle hire, accommodation, meals and any other incidental and/or related expenses, (e) is the name and official role of each accompanying support and protection staff and (f) is the corresponding cost breakdown for each individual, disaggregated by transport such as airfare and vehicle hire, accommodation, meals and any other incidental and/or related expenses and any additional and/or once-off costs associated with each specified trip such as visa fees, travel insurance and/or conference registration fees? REVISED REPLY:

(a) , (c), (d), (e), (f) A breakdown of the audited 2024-2025 financial year is provided in Annexures A and B below.

(b) The Ministry undertakes international travel to carry out the core mandate of the Department of Trade, Industry and Competition. Travel is either at the request of the President, particularly for State Visits, or through our membership of global structures where South Africa's interests must be defended or advanced (for example in the World Trade Organisation), or meetings with investors.

In the period under question, the travel undertaken focused on the following four categories:

- Promoting African trade, investment and industrialisation.
- Meeting with major trading partners, including State Visits.
- Meetings where South Africa is a member of the International Organisations.
- Travel to set out the case for investment in South Africa.
