- 1. the dtic's 2022/2023 APP is informed by both the country's imperatives to address high unemployment, poverty and inequality; and the urgent need to improve economic performance and inclusive growth
- 2. It builds on the innovation introduced in 2021, namely that of greater integration of the work of the Department, through 'Joint KPIs'.
- 3. In this APP, that idea is taken further through the introduction of three succinct Outcomes that replace the sprawling 17 previous Outcomes, bringing greater coherence to the work of **the dtic**.
- 4. The three outcomes are **industrialisation** to promote jobs and rising incomes, **transformation** to build an inclusive economy, and a **capable state** to ensure improved impact of public policies.

Introduction

- The Annual Performance Plan sets out the work to be undertaken by **the dtic** during the 2022/23 financial year, to achieve the overall goals of the 6th Administration.
- The APP maintains continuity with regard to the priorities identified in the 2019 dtic Budget Speech at the start of the 6th Administration:
 - building dynamic industries through partnerships;
 - expanding exports through AfCFTA and trade policy measures;
 - improving the climate for investment and the level of fixed investment in the economy;
 - spatial equity through targeted policies;
 - transformation of economy; and
 - · building a capable state.
- It takes account of the refocus to economic resilience introduced in the 2020 APP
- It builds on the focus on greater integration across the ten dtic programmes and with the 18 dtic entities
 introduced in the 2021 APP

Introduction

- **1. the dtic's** 2022/2023 APP is informed by both the country's imperatives to address high unemployment, poverty and inequality; and the urgent need to improve economic performance and inclusive growth
- 2. The new APP is aligned more clearly with the February 2022 SONA priorities
- 3. Three outcomes are defined for all the work of the dtic and entities
 - Industrialisation
 - Transformation
 - · Capable State.
- 5. The KPIs have been significantly rewritten and expanded, based on lessons from past implementation.

Align With SONA Priorities

The SONA in February 2022 set out a post Covid-19 recovery and reconstruction vision based on reforming the economy and rebuilding institutions. The new **dtic** APP takes account of a number of SONA priorities, including:

- Scaling up investment levels and local industrial production, including of health products and infrastructure;
- Focusing on sectors, including the social economy; agro-processing (sugar, poultry, hemp and cannabis, fruit, manufacturing (furniture, steel, clothing and footwear) and global business services
- Climate change, including renewable energy, electric vehicles and green hydrogen
- Implementation of the AfCFTA
- Youth employment; promoting small businesses; and spatial equity through the District Development Model
- Combating corruption and crime; including addressing the challenge of scrap metal theft
- Promoting the ease of doing business, including cutting red tape
- · Building a capable, ethical and developmental state and
- The call for deeper partnerships through the social compact

Align With SONA Priorities

- The APP contributes to President Ramaphosa's SONA mission to "revitalise our economy and end the inequality and injustice that impedes our progress."
- In response to the President's call for a "comprehensive social compact to grow our economy,
 create jobs and combat hunger", the dtic has adopted social compacting across our programmes,
 through initiatives like Masterplans and Export Networks
- In response to the President's call for to cut red tape across government, every dtic programme will be required to identify and report on concrete steps to streamline their operations
- In response to the President's call to reinforce "Africa's health sovereignty", the dtic continues to
 work to build the COVID-19 economy into a sustainable base for a reinvigorated healthcare sector,
 including through a rapid expansion in vaccine production
- In response to the President's call to restore the effectiveness of core network infrastructure such as energy and logistics, the dtic is supporting projects such as the REIPP and Transnet's reform drive
- The dtic has already contributed to the President's announcement of the Fourth South African Investment Conference, with pledges of R336.8 billion in new investment

Building On Strengths; Learning From Weaknesses

- A number of successes achieved during the past financial year have helped to inspire the work for the new
 APP and similarly, lessons drawn from weaknesses and challenges have been incorporated in the APP
- Successes that are drawn on:
 - The rollout of more locally-made health-care products and the turnaround in key sectors of manufacturing
 - The partnerships with firms to improve investment and job-creation, as part of reciprocal commitments when utilising public resources
 - Targeted use of competition and trade measures where warranted by the evidence
 - Flexibility and agility by entities in provision of support, eg post the July 2021 unrest
- Key weaknesses that are addressed:
 - Uneven local economic development (SEZs/Industrial Parks)
 - Weak export promotion connection with industrialisation
 - Uneven coordination with other parts of Government

What We Are Seeking To Do With The APP

- The revision of the outcomes has been accompanied by a more detailed set of outputs and output indicators, which are more clearly aligned. There are 151 output indicators in the APP, all connected to the three overarching outcomes.
- The indicators are more precisely framed than the previous APP, incorporating the learnings from one year of working with the new integrated approach.
- The APP requires a different way of working by the department and its entities. Following the adoption of the APP, the department is putting detailed implementation plans in place accompanied by a training programme for staff
- Changes to the Strategic Plan will see outcomes reduced from 17 to an integrated set of the three,
 allowing for a more coordinated and focused department.

Outcome 1: Industrialisation

Outcome 1: Industrialisation to promote jobs and rising incomes

In this area the goal is to contribute to building dynamic firms in the South African economy through a combination of efforts in partnership with the private sector, focusing on growth opportunities in the domestic market (through localisation, sector partnerships, beneficiation, promoting the green economy and fostering higher levels of investment) and building a wider export market (particularly in Africa) to assist with scale; and combining demand-creation with supply-side reforms at economy, sector and firm level to build industrial competitiveness and support job-creation.

The Industrialisation outcome consists of five focus/priority areas:

- 1. Sector partnerships and social compact through master plans and firm/sector level initiatives
- 2. Localisation, beneficiation and COVID industrial production initiatives
- 3. Increased and diversified exports with other African countries and to other global markets
- 4. Green economy initiatives to shift to a less carbon-intensive industry
- 5. **Investment initiatives** to increase the level of investment

Outcome 2: Transformation

Outcome 2: Transformation to build an inclusive economy

In this area the goal is to build economic inclusion through transformation programmes in three broad areas: Addressing structural challenges to growth through active competition policies, particularly where concentration levels in the market limit new entrants and small and medium businesses; Policies that promote spatial transformation, enabling more balanced growth between rural and urban and between provinces; and Strengthening inclusivity/transformation in the quality of growth, including broadening ownership and more inclusive corporate governance models.

The Transformation outcome thus contains the three focus/priority areas:

- 1. Ownership transformation: Promoting a greater spread of ownership in the economy (black industrialists, women and youth) and worker empowerment including through review of the impact of current policy.
- 2. Structural transformation: Addressing economic concentration and supporting SMMEs.
- 3. Spatial transformation: Promoting equitable spatial development through District Model Reporting and integration of work into 52 spatial units; and developing a new model for district spatial industrial initiatives (including SEZs and Industrial parks model) and promoting the township economy.

Outcome 3 : Capable State

Outcome 3: Capable State to ensure improved impact of public policies

In this area the goal is to build greater capacity so that national objectives are achieved through a new culture of partnership in the economy, characterised by greater responsiveness and nimbleness by the department and its 17 entities, which includes promoting smart regulation (through cutting red-tape, ensuring fit-for purpose and effective regulation and reviewing internal processes and legislation/regulations) and working closely with other parts of the state to forge a social compact with business and labour.

The Capable State outcome contains the five focus/priority areas:

- 1. **Department:** Building strong capacity in **the dtic** and streamlining its work.
- 2. Entities: Building the entity staffing, governance capacity, quick-response; developing shared services; and rationalisation of functions and integration of work between entities and with the department.
- Smart regulation: Address red tape and compliance in internal processes and in legislation and regulations; enable fit-for purpose regulations.
- 4. Coordination within the state: Ensuring effective support functions from other public entities to achieve APP outcomes.
- 5. Contribute to social compacts with other social partners.

Relationship Between The Three Outcomes

The three outcomes have a complex and overlapping relationship

- Industrialisation is the defining focus **of the dtic**; yet in conditions of South Africa, it is imperative to promote transformation as part of industrialisation both for reasons of economic inclusion and stability; and to widen the talent pool and deepen the base for growth itself.
- At the same time, the dtic has a legal mandate on transformation that goes beyond the dtic's industrial sectors and covers the wider economy. Similarly, competition policies are not confined only to the industrial sectors.
- The capable state is a critical requirement for fruitful partnerships with the private sector in order to drive industrialisation. At the same time, **the dtic**'s mandate requires state capability in areas not confined to industrialisation like consumer policy and regulation of alcohol and the lotto.

A Co-ordinated Approach

Concentrating the work of the dtic around these three Strategic Outcomes allows for better **coordination of work** across the dtic's eighteen entities. For example

- In the Transformation Outcome, firms in the Township Economy should be able to access dedicated resources from the NEF and IDC, while being protected from unscrupulous lenders through the NCR's programme; and can demonstrate the quality of their work through new standards outreach by SABS, while being protected from substandard imports by the NRCS and ITAC's permit and inspection regimes.
- In the **Industrialisation Outcome**, entities are laying the groundwork for the green economy, with NMISA and SANAS building a technical ecosystem that can incorporate new technologies like green hydrogen, the ECIC can help South African firms access opportunities in Africa's investment in renewable energy, and the Competition Commission prioritising oversight of the energy sector to ensure fair access for IPPs.
- In the Capable State Outcome, entities have made commitments to reduce turnaround times, improve responsiveness, and combat corruption.
- Similar collaboration continues **beyond the dtic's entities**. For example, the Constitutional Court's judgement on the Preferential Procurement Regulations requires greater work with individual organs of state; and a revamp of the procurement legislation to give effect to the public policy objectives.

The DTIC's Approach To Performance Indicators

The work of the dtic and its entities will focus on the three strategic focus areas outlined above. the dtic and its entities will also be contributing to the Economic Reconstruction and Recovery Plan (ERRP) announced by the President in October 2020.

the dtic seeks to contribute to inclusive growth and job creation, by pursuing inter alia the following:

- Increase the level of investment in the economy, by securing pledges for fresh investment in South Africa of at least R120 billion largely from the private sector, during the 12-month period and work with private firms to enable pledged investment to be realised.
- Improve industrialisation of the economy, through contributing during the financial year in selected projects, to the target of R200 billion additional local industrial output over a five-year period.
- Support for structural transformation of firms and sectors through customised packages of support of R22 billion
 by the dtic and its entities (comprising industrial funding, competitiveness enhancement programmes or working
 capital to SMEs).
- Maintaining South Africa's share of manufacturing global exports, worth about R600 billion through its support and risk-cover on transactions valued at R8,2 billion expected to be issued; and improving the composition of exports (with more value-addition), the composition of exporters (with more previously-excluded demographic groups) and the spatial distribution of exporting firms.


The DTIC's Approach To Performance Indicators

In order to manage the quality of delivery in these complex areas, **the dtic** has developed a number of products, including the following:

- **Financial support**, with a focus on support to black industrialists, women- and youth-owned enterprises, and the green economy, and which generates investment and local procurement
- **Draft Bills** for five pieces of legislation, including: the Patents Bill, Designs Amendments Bill, Companies Amendment Bill, National Gambling Amendment Bill
- Reviews and revisions to regulation and legislation in five areas, including: anti-dumping investigations, safeguard measure investigations, tariff investigation, the B-BBEE framework, and liquor policy.
- Mous and social compacts with industry on investment, jobs and output
- Trade protocols and rules of origin proposals
- Export networks and export plans put in place
- SEZs and Industrial Parks initiatives, and a new framework for the dtic's spatial policy
- Strategic documents, including a roadmap for new energy vehicles, green hydrogen commercialisation
- Cutting Red Tape Reports identifying steps to reduce red tape across the dtic's programmes and entities
- Improved processes, systems and capacity for monitoring and evaluation, entity oversight, combatting corruption, and shared-use of internal capacity
- Presentations, inputs and engagements with the Cabinet, Parliament, NEDLAC, and other government entities
- Research reports and analytics systems
- Action Minutes and reports on work done



LEGISLATIVE PROGRAMME

Reviews and Amendments will be undertaken on the following:

- The Broad-Based Black Economic Empowerment (B-BBEE) policy, which includes the Strategy, the Act, Regulations, and the Codes of Good Practice.
- The Companies Act amendments will be processed, focused on ease of doing business, indicators on wage differentials and measures to combat money laundering and terrorism. Further amendments may be introduced addressing corporate governance and inclusion of workers in boards of companies.
- The work on the **Copyright Amendment Bill and Performers' Protection Amendment Bill** will continue in Parliament towards finalisation, to ensure a rigorous and effective legislative regime for the creative industry and other copyright-based industries, with strengthened legal protection for rights holders.
- The National Credit Amendment Bill will be reviewed to ensure that over-indebted, low-earning consumers receive cost effective debt relief.
- The National Building Regulations and Building Standards Act No. 103 of 1997 will be amended, in line with a decision of the Constitutional Court that required a reworking of Section 9 of the Act.
- The Special Economic Zone (SEZ) Strategic Framework will be developed to guide implementation of the SEZ Policy and Act (No. 16 of 2014), as well as the development of a policy for industrial parks to guide the establishment, development, operation and revitalisation of industrial parks in the country.

THE DTIC ALLOCATED BUDGET

INTRODUCTION AND BUDGET HIGHLIGHTS

Introduction

- APP provides the framework in which the department will align and utilise its financial and human resources.
- To drive the integrated work of the department, R10.8 billion is allocated for the 202/23 financial year.
- To bring greater coherence of the work of the dtic, stronger alignment of the budget to the APP is vital.
- To this end and to promote integration and common focus, the KPIs in each of the 10 programmes have incorporated the three outcomes, being, Industrialization; Transformation and a Capable State with the budget of R10.8 billion apportioned across these 10 programmes.

Budget Highlights

2021/22



 The department received additional allocation of R2.1 billion in 2021/22 (R1.3 billion to respond to the social unrest in July 2021 and the negative impact of COVID-19 pandemic – as well as R800 million for the Social employment Fund)

2022/23



- When compared with the 2021/22 financial year, the department's total expenditure is expected to decrease at an average annual rate of 3.7 per cent, from R11.8 billion in 2021/22 to R10.6 billion in 2024/25.
- Funding for the Social Employment Fund has been extended for additional 2 years at a value of R1.65 billion.
- The work in the Trade Policy programme includes amongst others the AfCFTA. Spending is expected to increase from R226.8 million in 2021/22 to R248.8 million in 2024/25.
- The work of expanding and diversifying exports to the rest of Africa through leveraging opportunities presented by the AfCFTA will be done through Trade and Investment South Africa programme. Spending is expected to increase from R443.1 million in 2021/22 to R451.7 million in 2024/25.
- Over the MTEF, the department will continue with the development and implementation of various sectoral master plans as part of the re-imagined industrial strategy

ALIGNMENT OF THE BUDGET WITH THE 3 STRATEGIC OUTCOMES

In support of the Re-imagined Industrial Strategy driven by Master Plans in priority sectors, some of the implementation instruments will include:

Industrialisation

- 1. **R4.4 billion** over the medium term (R1.3 billion in 2022/23) towards the Automotives.
- 2. **R1.8 billion** over the medium term (R599 million in 2022/23) towards the Retail-Clothing, Textile Footwear Leather (R-CTFL) for the labour-intensive sector with predominantly women workers and entrepreneurs.
- 3. **R197.5 million** funding support housed at the IDC towards the Furniture Growth Fund to assist enterprises in the furniture industry to improve their competitiveness, as well as assist companies in distress with bankable turnaround strategies in order to grow the industry and enable businesses to survive the current economic downturn.
- 4. **R121 million** over the medium term (R39.5 million in 2022/23) towards the Downstream Steel Industry Competitiveness Fund at the IDC
- 5. **R1.1 billion** over the medium term (R365.6 million) towards the BPS

Transformation

- 1. **R1.3 billion** over the medium term (R374 million in 2022/23) towards the Black Industrialist programme
- 2. **R4.9 billion** towards spatial work through the SEZs and Industrial Parks






- As part of the work on industrialization to promote jobs, the department will provide support through the clothing and textiles competitiveness programme, which has a budget of R1.8 billion over the medium term. It expects to provide financial support to 404 clothing and textile firms.
- Expenditure in the *Industrial Financing* programme is expected to decrease at an average annual rate of 4.8 per cent, from R6.2 billion in 2021/22 to R5.4 billion in 2024/25.
- Allocations to the *Industrial Financing* programme account for an estimated 49.3 per cent (R15.5 billion) of the department's expenditure over the MTEF period, mainly to fund incentive programmes.
- Allocations to the Manufacturing Incentives subprogramme account for an estimated 51.6 per cent of R7.6 billion of the Industrial Financing programme's budget over the medium term
- Spending in the programme's Infrastructure Investment Support subprogramme is expected to increase at an average annual rate of 0.4 per cent, from R1.76 billion in 2021/22 to R1.79 billion in 2024/25.
- The 2022/23 allocation to the special economic zones is R1.6 billion, followed by R135 million for industrial parks and R116.5 million for critical infrastructure.

Approximately **62.9% or R6.8 billion** will be disbursed as follows:

Manufacturing: 31%

- Includes programmes for Enterprise Investment; Automotive; CTFL, Supplier Cluster and Steel fund

Spatial: 28%

 Comprises of the SEZs, Industrial Parks, CIP, Tirisano Fund, Regional Industrial Development and Centurion Aerospace village

Services: 11%

- Comprises of the Global Business services and, Film and Television production incentive

Export: 6%

- Comprises of the Export Make-up scheme at the ECIC and EMIA

Transformation: 5%

- Comprises of the Black Industrialists support and the Women Empowerment fund.
- The Women Empowerment fund is established in partnership with the NEF. R141 million financial support from the ECF has been provided for the Women Empowerment Fund, which will be targeting enterprises and projects that are majority owned black women, youth and people with disabilities.

Innovation, technology and Skills: 18%

Comprises of programmes for National Foundry Technology network, Automotive supply chain competitiveness initiative, Fibre and textile, THRIP, Workplace Challenge, Itukise, Monyetla, SPII and SEF

Energy efficiency programme: 1%

- The National Cleaner Production, is a national programme of government that promotes the implementation of resource efficiency and cleaner production (RECP) methodologies.
